### THOUGHTS ON CHECKOFF AND THE REFERENDUM

First, I have to tell you I was appointed to the Promotion Board in early February and attended my first Board meeting in Portland, OR, two weeks later. So I admit to being highly biased in favor of a YES vote in the May referendum to keep the checkoff program going. A great deal of information was presented and I learned a lot at that meeting. But there was one item that leaped off the screen and startled me. More about that in a minute.

About two months ago a letter from a grower in Virginia was highly circulated throughout the industry. You may have received one. In it, he makes fun of the impact the campaigns of the last two years have had, saying, "impressions, whatever they are." We should understand that as growers we would not sell a single tree, wholesale or retail, if we had not made a good impression on the buyer. Maybe it's you personally, the quality of your product, your pricing, the way you do business, the way your farm looks, a combination of these and other impressions. However as an industry we have to acknowledge that we deal with several negative impressions which have built up over many years, promoted by other special interests. Real trees are unsafe, bad for the environment, messy, inconvenient, the list goes on and you know it well.

As growers, we accept that after putting a seed in the ground it takes more than ten years in most of the country to produce a saleable tree. The positive impressions we have made on the public the last two years are much like those seeds. The thing which startled me at the February meeting is how much impact we have already made in the first two years.

Responses were solicited after the season in a survey which covered four key areas. On the statement "Only real trees are 100% recyclable" 67% agreed. This was up from 64% two years ago. (these percentage increases seem small until set against the total population of the country). On the statement "Real trees are better for the environment", 59% agreed, up 2% from two years ago. 56% agreed with the statement "Farmers plant 1-3 trees for every one cut. This, too, was up 2% from two years ago. Finally, 54% said they knew artificial trees ended up in landfills where they would stay for thousands of years. This was up 3% from two years ago.

The positive impressions we have made the last two seasons really have had a surprising effect! It may be too soon to tell if that has carried over into increased sales but if we keep telling our story it will happen. Like that seed we put in the ground our message needs to be nurtured with a consistent investment in time and money.

Please vote YES to keep that little tree growing.

### JANUARY 2018 DIRECTORS MEETING

The January meeting of the MCTA Board of Directors was called to order at 5:10pm, January 8, 2018, by President Frank Zmidgrodski. Officers and Directors attending were Frank Zmidgrodski, Steve Higgins, Tom and Joanne Bond, Jim and Norma Corliss, Rob and Tammie Mulvey, Brett Mitchell, Tom McNeil and Lee Skillins. Guests attending were Mary Zmidgrodski, Len Price and Regina Mitchell.

Joe Reynolds of Downeast Magazine spoke to the Directors about methods the magazine uses to increase circulation to see if MCTA to see if MCTA could use any of these ideas to increase membership.

Meeting adjourned at 5:50pm for dinner and resumed at 6:20pm.

Executive Secretary Bond said she had not as yet been able to compile a membership list because members had failed to give her complete information. There was a long discussion of the role of the Executive Secretary as a go-between growers and buyers.

Treasurer Tammie reported the following account totals: General, \$16,522, Marketing \$213, Website \$208, Seed Orchard \$9,247, Meetings \$4,900 and Scholarship \$6,634. for a total net worth of \$37,723.

Jim Corliss commented that he planned to expand the wreath making demonstrations at Fryeburg Fair to the full eight days of the Fair. It was suggested that the score sheets for the tree and wreath exhibits be added to the website. Tom McNeil volunteered to see this was done.

Motion was made and seconded to drop membership in the Maine Tourism Association. Motion passed. Frank followed up on the presentation by Joe Reynolds by saying that the MCTA needs to find ways to interest prospective growers to join. Jim Corliss commented that we had just passed up a perfect PR opportunity to do that. The programs of all Associations meeting at the Ag. show were published in newspapers across the State. There was only a notice of our meeting but no program information was presented.

Len Price asked Board approval to raise the scholarships to \$1,000 for this year. Two scholarships have been approved. Motion passed.

Dugald Kell was unable to attend but submitted a written report on NCTA activities.

Lee Skillins reported on activities of the Ornamental/Horticultural Committee. No action was required.

Norma Corliss said 3,000 ornaments went out with the 300 Maine trees donated for Trees For Troops. There are already enough ornaments on hand for net year. Joanne announced she had raised enough money to purchase 600 ornament bags to cover the next two years.

Gary Fisher reported that Representative Pingree was interested in obtaining information regarding the difficulty of obtaining a reliable labor force.

There was a discussion of organizing short "twilight meetings" at locations around the state during the summer. No action taken.

The Mingo family will be hosting the MCTA annual meeting in September in Calais.

Jim and Norma Corliss offered to host the spring Directors meeting. Directors chose April 6th.

Meeting adjourned at 8:50pm.

The Spring Directors meeting of the MCTA was held at the home of Gary and Melba Fisher in Belfast, April 6, 2018. The meeting was called to order by President Frank at 6:32pm. Officers and Directors attending were Frank Zmigrodski, Tom and Joanne Bond, Rob Mulvey, Norma Corliss, Brett Mitchell, Doug and Dugald Kell, Tom McNeil and Lee Skillins. Guests were Regina Mitchell, Len Price, and Gary and Melba Fisher.

Norma explained that the reason Jim wasn't there was that he had had knee replacement surgery two weeks ago and was in a rehab facility.

Directors dispensed with reading the minutes of the January meeting. Joanne announced that Dave Rice is once again battling cancer. She announced that MCTA now has 117 members. Motion was made to make Doug Kell a lifetime member of MCTA. Motion passed. There is a developing problem with getting contact information from new members. Several solutions were discussed.

Treasurer Mulvey had prepared a report which was presented by Rob. General Fund \$18,487; Marketing \$201; Website \$1,158; Seed Orchard \$9,247; Meetings \$4,790; Scholarships \$6,034. Total net worth \$39,916. Treasurers reports was accepted.

Dugald said that NCTA is not planning a summer meeting this year and will probably partner with the Pennsylvania Association in 2019. It appears that NCTA membership is stabilizing at between 300 and 400 members. He reported on the Harris poll conducted by NCTA after the season.

Len Price said that although 2 scholarships were approved for \$1,000 each only one has been paid. The recipient of the other has not submitted the required paperwork.

A motion was made to dedicate \$2,000 to an ad in Downeast magazine. Motion failed for lack of a second.

Norma Corliss announced that Jim had been selected to the CTPB and attended a meeting of the Board held in conjunction with the Northwest Association in Portland, OR in February. Motion was made for the MCTA to support the activities of the CTPB. Motion passed.

Len Price spoke about the twilight meetings which Massachusetts holds in the summer. There was discussion whether it would be a good idea for Maine. Motion was made to make \$200 available to plan two twilight meetings for this coming summer. Motion passed.

Motion was made to donate \$100 to the Ag. in the Classroom project. Motion Passed.

SEED ORCHARD Frank Zmigrodski

At the fall meeting Larry Downey reported that 7,000 transplants would be available for sale in the spring of 2018. Those that previously responded to surveys posted in the MCTA newsletter were given the opportunity to purchase these transplants. Larry Downey reports that the first planting in 2015 has resulted in 29,000 seedlings which are mostly 6-12 inches, with many in the 10-12 inch range. The seeds planted in 2016 suffered from poor germination resulting in 7,800 seedlings while the 2017 planting currently has 21,000 surviving seedlings. Larry's goal is to raise 30,000 seedlings, or more annually, to satisfy the anticipated needs of MCTA members. This is a critically important project for the MCTA as our association receives \$.10 for every MCTA tree Downey Nursery sells. All members are encouraged to purchase future planting stock from Downey Nursery when available.

# **NCTA Director's Report**

Dugald Kell Jr

### **Legislative Issues**

You may recall that NCTA, through its affiliation with AmericanHort (formerly the American Nursery & Landcape Association), has the benefit of a lobbyist in Washington to monitor legislation and put forward the interests of Christmas tree growers. Our lobbyist, Craig Regelbrugge, issued his monthly report at the end of last month. Following is an edited version of that report:

### Farm Bill Advances, But Path Uncertain

In April, the House version of the 2018 Farm Bill was introduced and approved by the House Agriculture Committee. NCTA and AmericanHort are primarily focused on several programs that are contained in the Horticulture Title. In that respect, the House proposal is really a "status quo" bill. The House bill highlights, at this stage:

<u>Specialty Crop Research Initiative</u> – Funding would be \$80 million per year, though \$25 million continues to be dedicated to solving threats to the citrus industry. We continue to seek funding of \$80 million for all specialty crops.

<u>Plant Pest and Disease Mitigation and Disaster Prevention Program</u> – Funding would continue at \$80 million per year. These programs provide 'first dollars' for responding to and mitigating invasive plant pest threats. One example – Dr. Gary Chastagner just received approval for a \$36,514 project to develop a treatment protocol for Megastigmus larvae in imported conifer seed shipments.

<u>Specialty Crop Block Grants</u> – These grants, mostly administered by the states, have funded numerous research, statistics, and marketing programs benefiting our industries. The legislative proposal would fund this program at \$85 million per year, \$5 million of which would go toward multi-state projects.

Do these programs really mean anything for Christmas tree producers? Dr. Chastagner, go-to researcher for our industry, puts it this way: "I often tell growers that my Christmas tree program would not exist without the support I receive from the Specialty Crop Block Grant program." And Chastagner has received funding in recent years from all three programs mentioned above.

However, the Farm Bill may face a tough road ahead, because it does not have the bipartisan support that prior Farm Bills have typically enjoyed.

### **Future Meetings and National Tree Contests**

The 2019 NCTA Board meeting and National Tree Contest will be hosted by the Pennsylvania Christmas Tree Growers Association in conjunction with their summer meeting in August. A host farm has yet to be named. For the next biannual meeting, some discussion has been held with the North Carolina Christmas Tree Association about hosting the 2021 NCTA Board meeting and National Tree Contest. It would be held in conjunction with their summer meeting in that year. NCTA is also seeking to identify other states that may also have interest in hosting NCTA.
